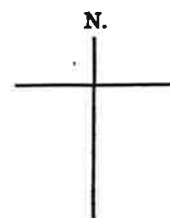

For furnishing all labor, materials and equipment necessary and required for the emergency demolition of the following structure:


293 East 3rd Street      U.B. 88/68      Block 373      Lot 59
